- (2) At least two years' experience of proof reading in printing press or in a Government of a Central or State and Union Territory Administration.
- (3) Passed High School with Hindi as a medium of Examination.

NOTE: I Qualification are relaxable a discretion of the SSC or competent authority, for reasons to be recorded in writing in the case of candidates otherwise well qualified.

NOTE-II The qualifications regarding experience is relaxable at the discretion of the SSC or competent authority, for reason to be recorded in writing in the case of candidates belonging to SC or ST if at any stage of selection the SSC or competent authority of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the vacancies reserved for them.
